# STUDENT BOARD REPORT

# SUPERINTENDENT'S REPORT

Superintendent Greg Plutko thanked our dedicated staff whether it be our teachers, classified staff, nutrition services workers, or custodians for all of the support we have given each other.

Dr. Plutko dedicated his report to the subject of grading and how that will be accomplished during this unprecedented time. Dr. Plutko noted that it is very difficult to match with a traditional grading system during this non-traditional form of instruction. Dr. Plahy provided information on the topic and shared that the credit/incomplete is by far the best way to protect everyone. Dr. Plutko summed up by saying there is no one perfect answer on what we do to protect our students and what they have worked hard to achieve. We are working hard to do what is best for our students.

## RESOLUTION DECLINING TO CURE AND CORRECT BOARD ACTION OF MARCH 10, 2020 MEETING

**WHEREAS**, this Board, at its March 10, 2020 regular meeting, in closed session, approved the release and reassignment of Certificated Management employee #7516 pursuant to Education Code Section 44951; and

**WHEREAS**, on or about March 11, 2020, the District provided Certificated Management employee #7516 with notice of the release and reassignment as required by Education Code Section 44951; and

**WHEREAS**, on or about April 1, 2020, Certificated Management employee #7516 submitted a demand to cure and correct pursuant to Government Code Section 54960.1 with the Board of Education alleging the Board acted in violation of Government Code Section 54957.7(a) and Government Code Section 54957 (b)(2); and

**WHEREAS**, the agenda for the March 10, 2020 meeting included the above-described action to be taken in closed session as "Public Employment Discipline/Dismissal/Release;" and

**WHEREAS**, prior to going into closed session, Board President, Eric Padget, publicly announced all reasons the Board was entering closed session as required by Government Code Section 54957.7(a); and

**WHEREAS**, because Certificated Management employee #7516 was released and reassigned pursuant to Education Code Section 44951, the Board's action was "not for cause;" and

**WHEREAS**, Certificated Management employee #7516 was not provided with a 24 Hour Notice as described by Government Code Section 54957(b)(2); and

WHEREAS, the California Court of Appeal has recently concluded that a certificated administrator is not entitled to a notice described in Government Code Section 54957(b)(2) where the administrator is being released and reassigned from his or her position. *Hayes v. Temecula Valley Unified School District* (2018) 21 Cal.App.5th 735, 754; and

**WHEREAS**, Government Code Section 54960.1 lists a narrow set of statutes that are subject to the "cure and correct" process and Government Code Section 54957.7(a) is not one of those statutes.

## NOW, THEREFORE, be it resolved as follows:

The April 1, 2020 demand by Certificated Management employee #7516 to cure and correct the action taken in closed session to release and reassign the employee pursuant to Education Code Section 44951 is denied because the Board complied with Government Code Section 54957.7(a).

Even if the Board did not comply with Government Code Section 54957.7(a), pursuant to Government Code Section 54960.1, an alleged violation of Section 54957.7(a) is not proper grounds for a demand to cure and correct.

The April 1, 2020 demand by Certificated Management employee #7516 is also denied because the release and reassignment of Certificated Management employee #7516 was "not for cause" and notice pursuant to Government Code Section 54957(b)(2) was not required. *Hayes v. Temecula Valley Unified School District* (2018) 21 Cal.App.5th 735, 754.

The allegations made in Certificated Management employee #7516's April 1, 2020 demand are clearly frivolous and totally lacking in merit within the meaning of Government Code Section 54960.5.
