## EXHIBIT A

## Tentative Agreement

## Article 1: AGREEMENT

This agreement is entered into this $19^{\text {th }}$ day of January, 2010 by and between the Board of Education of the Placentia-Yorba Linda Unified School District, hereinafter referred to as "District" and the Association of Placentia-Linda Educators/California Teachers Association/National Education Association, hereinafter referred to as "Association". This agreement shall supersede any rules, regulations or practices of the District which are contrary to or inconsistent with the terms. This Agreement shall remain in effect until June 30, 2011.

For the year 2011-2012, the Association and/or District may each reopen the article on wages and benefits and two other articles at the choice of the Association and two other articles at the choice of the District.

## Article XVI: PROFESSIONAL DAY

## Add the following:

O. Notwithstanding any other provision of this agreement, bargaining unit members shall be furloughed with a pro-rata reduction of pay as follows:

2009-10 4 days (February 23, 2010; April 2 and 12, 2010; May 28, 2010)
2010-11 6 days (TBD through negotiations of the 2010-11 work calendar)
The actual furlough days for the 2010-11 school year shall be determined by a joint sub-committee of the bargaining teams. This provision shall sunset and no longer be in affect at the end of the agreement.

## Article XIV: WAGES and BENEFITS

Under Health Benefits at the end of item 6 add:
Effective July 1, 2010 the agreed upon medical plan for the low Anthem HMO coverage shall include a Select Network.

## Article XI: Cläss Size

H. For the term of this agreement:

1) Industrial Arts, Vocational Shops, Fine Art, and Homemaking (Lab) shall be modified from 33 to 36 ; Physical Education shall be modified from 50 up to 55 and Continuation School from 20 to 25.
2) In the event that maximums are exceeded beyond any continuous three-week period, the relief measures of item C above will not be implemented.

This provision shall sunset and no longer be in effect at the end of the agreement.

## Article X: Leaves and Absences

1) Modify Article 10, Section $A$ (1) to include the District's on-line substitute calling system.
2) Modify Article 10, Section $C$ (1) (a) to include sick leave use for family members pursuant to Labor Code 233.
3) Modify Article 10, Section $C(1)(f)$ to eliminate the word "prognosis."
4) Modify Article 10, Section $F$ to eliminate reference to eighteen (18) months and just use COBRA.
5) Delete Article 12 , Section $\mathrm{D}(2)$ and remove reference from $\mathrm{D}(3)$.
6) Add Article 12 , Section $D(10)$ as follows:

Unit members shall have the right to trade positions for one year if both unit members are properly credentialed and agree to the trade with the approval of all principals of the schools involved and the district Personnel Office. Upon the conclusion of the year, the trade may become permanent if both unit members and both principals agree to the permanent change.
7) Add Article 12, Section $E(12)$ to read as follows:

Unit members that receive a District initiated transfer due to an enrollment decline at the unit member's school shall have the option to return to their original school site if an opening exists before the start of classes. If an opening occurs after the start of school, the employee shall be considered for the opening upon request.
