RESOLUTION NO. 2

RESOLUTION OF THE BOARD OF EDUCATION OF THE PLACENTIA-YORBA LINDA UNIFIED SCHOOL DISTRICT AUTHORIZING THE EXECUTION AND DELIVERY OF A SITE LEASE AND SUBLEASE AND OTHER ACTS RELATING TO THE TEAM ROOMS FOR THE BRADFORD STADIUM FACILITY IMPROVEMENTS PROJECT AT VALENCIA HIGH SCHOOL

WHEREAS, the Placentia-Yorba Linda Unified School District ("District") desires to construct improvements on a portion of the Valencia High School campus as a lease-leaseback project whereby the District will lease the Site which the District owns to New Dimension General Construction, who will construct the Project thereon and lease the Project and underlying Site back to the District;

WHEREAS, Education Code Section 17406 authorizes the governing board of a school district, without advertising for bids, to let to any person, firm or corporation any real property belonging to the district if the instrument by which such property is let requires the lessee to construct on the demised premises, a building or buildings for use of the school district during the term thereof, and provides that title to the building shall vest in the school at the expiration of that term;

WHEREAS, it is in the best interest of the District to cause the construction of the Project through lease and sublease of the Site pursuant to Education Code Section 17406;

WHEREAS, in order to complete the Project, it is necessary that the District enter into the Site Lease, in which the Site will be leased to New Dimension General Construction, and a Sublease which provides for the sublease of the Site and the lease of the Project by New Dimension General Construction, to the District, and that certain other action be taken and authorized;

WHEREAS, the Sublease includes construction provisions with which New Dimension General Construction, shall comply with respect to construction of the Project ("Construction Services Agreement");

WHEREAS, pursuant to Section 17402 of the Education Code, the plans and specifications for the Project must be prepared and adopted prior to entering into Site Lease and the Sublease agreement for the Project ("Plans and Specifications");

WHEREAS, the Plans and Specifications have been approved by the Division of State Architect ("DSA");

WHEREAS, in order to ensure that moneys sufficient to pay all costs will be available for the Project, the District desires to appropriate funds for the Project from its current fiscal year as provided by the Sublease;

WHEREAS, the Board has been presented with the Plans and Specifications for the Project and has examined and approves of such documents, subject to minor revisions, if any, by DSA, and subject to the delegation of authority provided by the Board as set forth below;

WHEREAS, the Board has been presented with the form of each document referred to herein relating to the transaction contemplated hereby and the Board has examined and approved each document and desires to authorize and direct the execution of such documents and the consummation of such transaction, subject to the delegation of authority provided by the Board as set forth below;

WHEREAS, all acts, conditions, and things required by the laws of the State of California to exist, to have happened and to have been performed precedent to and in connection with the consummation of the transaction authorized hereby, do exist, have happened and have been performed in regular and due time, form and manner as required by law, and the District is now duly authorized and empowered, pursuant to each and every requirement of law, to consummate such financing for the purpose, in the manner, and upon the terms herein provided.

NOW, THEREFORE, THE BOARD OF EDUCATION OF THE PLACENTIA- YORBA LINDA UNIFIED SCHOOL DISTRICT DOES HEREBY RESOLVE, DETERMINE, AND ORDER AS FOLLOWS:

Section 1. Recitals. All of the recitals herein contained are true and correct.

Section 2. <u>Site Lease and Sublease</u>. The form of agreement entitled "Site Lease" and the form of agreement entitled "Sublease" (with Construction Services Agreement attached thereto as Exhibit "D"), each presented to this meeting and each to be entered into by and between the District and New Dimension General Construction, which together provide generally for (i) the lease by the District of the Site to New Dimension General Construction, (ii) the sublease of the Site and the lease of the Project by New Dimension General Construction, to the District, and (iii) the payment of certain lease payments by the District under the Sublease in an amount equal to the aggregate construction costs for the Project as set forth in the Construction Services Agreement ("Lease Payments") are hereby approved subject to any revisions which are acceptable to both District's Superintendent ("Superintendent") and District's legal counsel. The Superintendent or their designee is hereby authorized and directed, for and in the name and on behalf of the District, to execute and deliver to New Dimension General Construction, such agreements, once finalized, pursuant to the delegation of authority provided for hereby.

Section 3. <u>Approval of Process</u>. The Governing Board hereby approves of the lease-leaseback process and approves of the Guaranteed Maximum Price amount of FIVE HUNDRED SEVENTY THREE THOUSAND, FOUR HUNDRED TWENTY DOLLARS (\$573,420.00) plus a District Contingency amount of FIFTY-SEVEN THOUSAND, THREE HUNDRED FORTY TWO DOLLARS (\$57,342.00), for a total amount of SIX HUNDRED THIRTY THOUSAND, SEVEN HUNDRED SIXTY TWO DOLLARS (\$630,762.00), for the construction of the Project pursuant to the terms of the Construction Services Agreement.

Section 4. <u>Approval of Plans and Specifications</u>. The Governing Board hereby approves of the DSA-approved Plans and Specifications for the Project.

Section 5. <u>Validation Action</u>. The Board hereby authorizes District counsel to file and litigate an appropriate validation action, as required, in the appropriate court with respect to the construction of the Project and the matters approved by this Resolution.

Section 6. Other Acts; Delegation. The District's Governing Board hereby approves a delegation of authority and appoints the District Superintendent, or the designee of the District Superintendent, who is/are hereby authorized and directed, to execute and deliver the Site Lease and Sublease as provided by Section 2 above, execute and deliver documents and/or negotiate documents with New Dimension General Construction, and as required execute court pleadings or documents necessary to effectuate the prompt litigation of the validation action, and to do any and all things necessary, in consultation with the staff, that they may deem necessary or advisable in order to effectuate the purpose and intent of this Resolution, all subject to ratification of the Board of Education, if necessary. Said delegation shall be valid during the construction of the Project, or until otherwise rescinded by the Governing Board.

RESOLUTION FOR THE BOARD OF EDUCATION OF PLACENTIA-YORBA LINDA UNIFIED SCHOOL DISTRICT ACTING AS THE LEGISLATIVE BODY OF THE COMMUNITY FACILITIES DISTRICT NO. 1 AUTHORIZING AND PROVIDING FOR THE LEVYING OF SPECIAL TAXES FOR COMMUNITY FACILITIES DISTRICT NO. 1

WHEREAS, the Board of Education of Placentia-Yorba Linda Unified School District (the "Board") has heretofore taken proceedings pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, (the "Act") for the establishment of Community Facilities District No. 1 (the "District") for the purpose of providing educational facilities for the use of residents of the District; and

WHEREAS, following a special election of the qualified electors of the District, this Board on November 12, 2002 acting as the governing body of the District, adopted Ordinance No. 1 ("Ordinance") which provided for the levying and collection of Special Taxes within the District, "as provided in the Act and Ordinance and as approved by the qualified electors"; and

WHEREAS, it is now necessary and appropriate that this Board levy and collect the Special Taxes for Fiscal Year 2011-2012, by the adoption of a resolution as specified by the Act and Ordinance:

NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

Section 1. In accordance with the Act and Ordinance, there is hereby levied upon all properties within the District which are not otherwise exempt from taxation under the Act or Ordinance the special taxes for Fiscal Year 2011-2012 set forth in the Ordinance at the tax rates as set forth therein and in Exhibit "A" hereto, as may be amended without further action of the Board to reflect updated information on assessor's parcel numbers from the County of Orange. The Assistant Superintendent, Administrative Services, is hereby authorized and directed to establish the final rates to be levied, which final rates shall not exceed the maximum rates.

<u>Section 2.</u> The above-authorized special taxes shall be collected in the same manner as ad valorem property taxes on the secured roll by the Treasurer-Tax Collector of the County of Orange and shall be subject to the same penalties and the same procedure and sale in cases of delinquency as provided for such ad valorem taxes.

<u>Section 3.</u> The Clerk and Assistant Superintendent, Administrative Services, are hereby authorized to transmit a certified copy of this Resolution to the Orange County Assessor and the Treasurer-Tax Collector, together with other supporting documentation as may be required in order to place said special taxes on the secured property tax roll for the Fiscal Year 2011-2012 and to perform all other acts which are required by the Act, Ordinance or by-law in order to accomplish the purpose of this Resolution.

Orange Unified School District Autism Spectrum Disorder Added Authorization MEMORANDUM OF UNDERSTANDING

Exhibit A

This Memorandum of Understanding (MOU) is entered into by and between the Orange Unified School District, hereto fore called the "OUSD" and Placentia Yorba Linda Unified School District heretofore referred to as "PLYUSD". This MOU will delineate the agreements, responsibilities, terms, and reimbursements for the OUSD to provide Autism Spectrum Disorder Added Authorization (ASDAA) coursework, training and credentialing support services to teachers within the PLYUSD District.

OUSD PROGRAM RESPONSIBILITIES:

OUSD agrees to:

- A. Act as approved Program Sponsor in accordance with the Orange Unified School District Beginning Teacher Support and Assessment (BTSA) Induction/Education Specialist/Autism Spectrum Disorder Added Authorization and the California Commission on Teacher Credentialing (CCTC).
- B. Provide on-line coursework (see attached syllabi) that meet the CCTC guidelines for approved programs.
- C. Provide on-line assignments and grading rubrics to ensure that Program Candidates are able to successfully demonstrate competence and course completion requirements for **no more than 30 participants per course**.
- D. Provide face to face training, and coursework calibration for PYLUSD Leadership/Instructors to ensure consistent implementation and fidelity to the OUSD Program across all PLYUSD participants.
- E. Provide observation demonstration site recommendations.
- F. Provide a structured forum for ASDAA Colloquium and Exit Panel Presentations.
- G. Provide an ASDAA recommendation for PYLUSD Participating Teachers who have successfully met all program completion requirements. Provide OUSD credential analyst who will be responsible for filing OUSD ASDAA recommendations with the CCTC for each PYLUSD candidate.
- H. Provide on-going collaboration, communication and OUSD Program evaluation and opportunities.

PYLUSD agrees to:

- A. Identify appropriate candidates for participation in the OUSD in accordance with CCTC guidelines.
- B. Provide high quality PYLUSD District leaders and instructors (see District Instructor Guidelines) to monitor and grade program participants' assignments based on approved course grading rubrics and guidelines.
- C. Provide PYLUSD technical support systems for the delivery of the on-line coursework. Complete, execute and return for each participating teacher the Signed OUSD Electronic Agreement one week prior to the opening of the course.
- D. Collaborate with OUSD in the selection and assignment of observation demonstration sites.
- E. Participate in structured ASDAA Colloquium and Exit Panel Presentation forums.
- F. Maintain fidelity to the grading rubrics and guidelines for course completion.
- G. Maintain on-going communication, collaboration and OUSD Program evaluation.

PYLUSD INSTRUCTOR REQUIREMENTS

The PYLUSD Instructors must meet the following requirements:

- A. Demonstrate certificated experience working with students with Autism Spectrum Disorder (ASD).
- B. Attend the OUSD Program ASD Instructors Training for program use and calibration at a time and date that is mutually agreeable by both parties.
- C. Grade all course assignments and monitor course blogs based on the rubrics established by the OUSD.
- D. Submit all grades to the OUSD as part of the ASDAA recommendation process.
- E. Schedule Course 1 Autism class demonstration site observations for Course 1 participates.
- F. Schedule an observation of Autism Practicum Candidates implementing ASD strategies within the context of one instructional lesson.
- G. Participate as a Practicum Project Presentation Exit Panel member and adhere to the OUSD rubric in grading candidate Practicum Projects.

TERMS and TERMINATION

This agreement shall be effective from July 1, 2011 until June 30, 2012 and is renewable annually, by mutual written agreement. The MOU may be amended by mutual consent of the parties and may be terminated by either OUSD Program or PYLUSD upon thirty (30) days advance written notification prior to the beginning of the semester.

PAYMENT

The PYLUSD agrees to pay OUSD per each participating teacher, as follows:

- Course 1 (12 weeks): \$175 Districts will be invoiced on a semester basis for each participant. Payment is due prior to the first week of class. Course fees are non-refundable.
- Course 2 and Practicum (12 weeks): \$275 Districts will be invoiced on a semester basis for each participant.
 Payment is due prior to the first week of class. Course fees are non-refundable.
- PYLUSD agrees to pay the instructors directly
- PYLUSD Candidates will pay their \$55 Credential Application Fee directly to the Commission on Teacher Credentialing.
- No later than 6 weeks after the completion of Course 2 the following must be received by OUSD:
 - · Final coursework grades,
 - Colloquium scores, and
 - Practicum grades

Receipt of these documents will result in a recommendation on behalf of the candidate to the Commission on Teacher Credentialing for the Autism Spectrum Disorder Added Authorization. Course completion documentation received more than six (6) weeks after completion of Course 2 may not receive a recommendation for the Autism Spectrum Disorder Added Authorization until the completion of the following semester.

INSURANCE

The parties shall maintain such general liability, property damage, workers' compensation, and auto insurance, and any other insurance as may be necessary, as is required to protect OUSD and PYLUSD. The Districts shall provide Certificates of Insurance, with Additional Insured Endorsements, indicating applicable insurance coverage prior to the commencement of work.

EMPLOYEE FINGERPRINTING

PYLUSD will assume responsibility as part of employment in the PYLUSD for all fingerprinting and "criminal record check certification".

GOVERNING LAW/FORUM SELECTION

This contract is made, entered into and executed in Orange County, California, and the parties agree that any legal action, claim or proceedings arising out of or connected with this Contract shall be filed in the applicable court in Orange County, California. The parties further agree this Contract shall be construed, and all disputes hereunder shall be settled, in accordance with the laws of the State of California.

INCORPORATION BY REFERENCE

Any exhibits referenced herein shall be incorporated and made a part of this MOU.

NO THIRD PARTY OBLIGATIONS

The execution and delivery of this MOU shall not be deemed to confer any rights upon, nor obligate any parties thereto, to any person or entity other than the parties hereto.

RECORD RETENTION AND INSPECTION

All parties shall have access to and the right to examine, audit, excerpt, copy or transcribe any pertinent records pertaining to this MOU. All records shall be kept and maintained by OUSD and made available to PYLUSD for a period not less than five (5) years.

OTHER TERMS AND CONDITIONS

All products and materials developed by the Program are the exclusive property of the OUSD. PYLUSD employees, staff, participating teachers, shall not have the right to disseminate, market or otherwise use the products or materials without expressed written permission of the OUSD designee.
