STUDENT BOARD REPORT

Student Board Member Noah Campuzano provided a report of the activities and events occurring at the district's high schools.

SUPERINTENDENT'S REPORT

Superintendent Greg Plutko thanked our new student board member, Noah Campuzano, for an informative and well-prepared student board report.

Dr. Plutko asked Assistant Superintendent of Business, Mr. David Giordano, to give an updated presentation on the budget later this evening since the legislature and the governor worked together and approved a new budget. The new budget is less dire than the previous one and will require fewer cuts. We will still need some reductions and will continue to be responsible in budgeting and tightening up in some areas. We are thankful but continue to be cautious. Dr. Plutko thanked Linda Manion and the APLE Association for their work on the MOU for furlough days, if needed. In light of the approved budget, we will not need to consider these furlough days at this time.

SUPERINTENDENT'S REPORT (Continued)

AB 77 placed restrictions on the new budget that was passed. Some of the restrictions had to do with the number of minutes for the new school year, distance learning, and layoffs. The challenge comes in some of the definitions they placed on distance learning, but the implementation is doable. At this time, Superintendent Plutko asked Dr. Candy Plahy to share some of the work we are doing with the steering committee and work groups in planning for return to school. Dr. Plahy spoke of the progress the work committees are making in the area of curriculum and instruction. School is a fundamental part of our students, parents, and staff lives, and we have been working diligently on that behalf. AB 77 did define some things we previously made decisions on, so we had to go back and reevaluate and find creative ways to plan that still allows for the safety of our students and staff. Dr. Plahy concluded that we are proud to offer Buena Vista Virtual Academy for online learning, and we are moving forward with plans that will meet the needs of all of our parents and students.

Dr. Plutko announced that all coaches are putting together plans for music and athletics to return on July 13. Based on recent information from the California Department of Public Health and the Orange County Department of Health, these programs may have to be postponed.

Superintendent Plutko took a moment to congratulate 84 classified employees who have received promotions within our district. He also recognized and thanked APLE for the donation toward yard signs created for the graduates as well as the PYLUSD retirees.

Dr. Plutko welcomed Dr. Linda Adamson to her new role as Assistant Superintendent of Educational Services. In conclusion, he announced that Deputy Superintendent Dr. Candy Plahy will be retiring on August 1, 2020. He praised her for being a legend in our District and described her as dedicated, intelligent, tireless, and committed. We feel sadness for us but joy for her and her family. She has been a great teammate, and we honor her at her last board meeting tonight.

RESOLUTION NO. 20-03

RESOLUTION FOR THE BOARD OF EDUCATION OF PLACENTIA-YORBA LINDA UNIFIED SCHOOL DISTRICT ACTING AS THE LEGISLATIVE BODY OF THE COMMUNITY FACILITIES DISTRICT NO. 1 APPROVING AND PROVIDING FOR THE LEVYING OF SPECIAL TAXES FOR COMMUNITY FACILITIES DISTRICT NO. 1

WHEREAS, the Board of Education of the Placentia-Yorba Linda Unified School District (the "Board") has heretofore taken proceedings pursuant to the Mello-Roos Community Facilities Act of 1982, as amended, (the "Act") for the establishment of Community Facilities District No. 1 (the "District") for the purpose of providing educational facilities for the use of residents of the District; and

WHEREAS, following a special election of the qualified electors of the District, this Board on November 12, 2002 acting as the governing body of the District, adopted Ordinance No. 1 ("Ordinance") which provided for the levying and collection of Special Taxes within the District, "as provided in the Act and Ordinance and as approved by the qualified electors;" and

WHEREAS, it is now necessary and appropriate that this Board levy and collect the Special Taxes for Fiscal Year 2020-21, by the adoption of a resolution as specified by the Act and Ordinance;

NOW, THEREFORE, IT IS HEREBY ORDERED AS FOLLOWS:

Section 1. In accordance with the Act and Ordinance, there is hereby levied upon all properties within the District which are not otherwise exempt from taxation under the Act or Ordinance the special taxes for fiscal year 2020-21 set forth in the Ordinance at the tax rates as set forth therein and in Exhibit "A" hereto, as may be amended without further action of the Board to reflect updated information on assessor's parcel numbers from the County of Orange. The Assistant Superintendent, Business Services, is hereby authorized and directed to establish the final rates to be levied, which final rates shall not exceed the maximum rates.

Section 2. The above-authorized special taxes shall be collected in the same manner as ad valorem property taxes on the secured roll by the Treasurer-Tax Collector of the County of Orange and shall be subject to the same penalties and the same procedure and sale in cases of delinquency as provided for such ad valorem taxes.

Section 3. The Clerk and Assistant Superintendent, Business Services, are hereby authorized to transmit a certified copy of this Resolution to the Orange County Assessor and the Treasurer-Tax Collector, together with other supporting documentation as may be required in order to place said special taxes on the secured property tax roll for the fiscal year 2020-21 and to perform all other acts which are required by the Act, Ordinance, or by-law in order to accomplish the purpose of this Resolution.

BE IT FURTHER RESOLVED, the Placentia-Yorba Linda Unified School District will establish a study course entitled "Ethnic Studies" for the District's high schools and will continue to review our curriculum with a particular focus in 2020-21 on our entire social studies curriculum in an effort to improve many criteria, including a fair and representative inclusion of underrepresented voices.

BE IT FURTHER RESOLVED, the Placentia-Yorba Linda Unified School District will establish a district and family task force as well as a student task force to support actions and behaviors that match the diverse needs of our community and will continue our district-wide professional development in all areas of racial bias and injustice.


